As a poet and writer, Jama has been commended for the Brunel African Poetry Prize, shortlisted for the Wasafiri Writing Prize, the New Poets Prize and James Berry Poetry prize, and longlisted in the National Poetry Competition. Their work has been published in magazines and journals such as Poetry Review, The Good Journal, Ambit, Ballast and Magma, and translated into French, German, Portuguese, Somali, Spanish and Swahili. Their writing has been commissioned by Arnolfini (Bristol), Hayward Gallery (London) and Ifa gallery (Brussels). Jama was a Cave Canem Fellow 2021. Jama is a Film London FLAMIN Fellow (2022) and a resident artist at Somerset House Studios.

Tamsin Hong is a contemporary international art curator based in London. Hong's research interests include women's knowledge systems and embodied practices. Formerly, she was Assistant Curator at Tate Modern where she specialised in performance; worked on African and Australian acquisitions; and co-curated the land rights exhibition *A Year in Art: Australia 1992*.
